Remove contact lenses, if present and easy to do. Continue rinsing. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. IF INHALED: If breathings difficult remove to fresh air and keep at rest in a position comfortable for breathing. IF ON SKIN: Gently wash with plenty of soap and water. Immediately call a POISON CENTER or doctor/physician. Call a POISON CENTER or doctor/physician if you feel unwell. Specific treatment: refer to Label or MSDS.		
Disposal : Add a little at a time (2 to 5g) to a large volume of water. After the reaction or solution is complete, allow it to run to normal waste, diluting with large amount of water. Any sand used to cover spillage should be thoroughly washed with water before disposal as normal waste.
