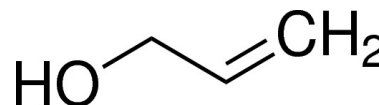

**DANGER**

**HAZARD STATEMENTS :** May cause respiratory irritation. May cause drowsiness or dizziness. Flammable liquid and vapour. Fatal in contact with skin. Fatal if inhaled. Toxic if swallowed. **PRECAUTIONARY STATEMENTS :**

Take precautionary measures against static discharge. Do not breathe dust/fume/gas/mist/vapours/spray. Avoid breathing dust/fume/gas/mist/vapours/spray. Do not get in eyes, on skin, or on clothing. Wash thoroughly after handling. Do not eat, drink or smoke when using this product. Use only outdoors or in a well-ventilated area. Avoid release to the environment. Wear protective gloves/protective clothing/eye protection/face protection. Use personal protective equipment as required. Wear respiratory protection.

**Response :** IF SWALLOWED: Immediately call a POISON CENTER or doctor/physician. IF ON SKIN: Gently wash with plenty of soap and water. IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF exposed or concerned: Get medical advice/ attention. Immediately call a POISON CENTER or doctor/physician. Call a POISON CENTER or doctor/physician if you feel unwell. Specific treatment is urgent (see MSDS). Rinse mouth. Do NOT induce vomiting. If eye irritation persists: Get medical advice/attention. Remove/Take off immediately all contaminated clothing. Wash contaminated clothing before reuse. Collect spillage.

**Disposal:**-- The waste chemical should be buried on a stage approved site. The liquids should be absorbed on sand.
